- No reporting obligations on foreign income/assets
- No Italian inheritance or gift tax on foreign-held assets
- Supported by double-tax treaties with over 100 countries

## Process & Timeline

- Typical timeframe: 90–120 days from application to visa issuance, depending on consulate efficiency and document readiness.
- Preparation – Secure Italian tax code, digital signature, proof of funds, legalised documents, and letter of intent.
- Online Submission – Apply via the Investor Visa for Italy portal; receive Nulla Osta (certificate of no impediment) within ~30 days if approved.
- Consular Application – Submit at your nearest Italian consulate within six months of Nulla Osta.
- Entry & Investment – Enter Italy within one year; complete investment within three months of arrival.
- Residence Permit – Apply at the Questura within 8 days of arrival; permit valid for three years from entry.
